### **Please pay close attention to the following details for Concert for the Causes:**

- The event will be **Saturday, May 6, 2023 with gates opening at 6:00pm at the Kern County Raceway** featuring **Jimmie Allen** and local Bands. • Vendors may set up starting at **10:00 AM** and must be completed by 5:30pm. • Vendors must bring their own table, pop-ups (if shade is desired), extension cords, generators (quiet), WiFi, and any other necessary materials/equipment. No items will be supplied by the event.
- Food Vendors must provide a copy of their food permit(s)
- All items must be cleaned up the night of the event.
- Cost to be a vendor is \$500 and is non-refundable. Must submit payment to secure space.

### **General Rules:**

- No alcohol or smoking (including vaporizers and chewing tobacco) allowed.
- No pets allowed (with the exception of service animals).

The organization listed on this contract shall reimburse BFBF, MARE, WHF and KCRP for damages to buildings, grounds and/or equipment arising from your use; normal wear is excluded.
